# What is Title I?

*“...is to provide all children significant opportunity to receive a fair, equitable, and high quality education, and to close educational achievement gaps.” Every Student Succeeds Act (ESSA)*



Schools that qualify for Title I deliver supplemental services through a targeted assistance (TAS) program or a school-wide plan under the schoolwide program (SWP) model.

# The Two Title I Models



**Schoolwide  
Program  
(SWP)**

May serve All Students at the School based on the needs assessment but must address the needs of students most at risk.

Serve Identified Title I Students based on multiple objective criteria

# What's required in a Schoolwide Title I program?



- Comprehensive needs assessment – Data analysis and annual evaluation of program
- Measurable goals, based on student data.
- Effective methods and instructional strategies based on research to address student needs
- Budget
- Process of monitoring the implementation of the planned actions

# Comprehensive Data Collection



## Student Achievement

- Review overall student grades
- Review overall student achievement breakdown by subgroup/demographics
- Analyze available standardized testing data
