Highlights from the July 2018 Action Meeting

Board Representative Reports

Cherry Hill High School West Representative Sonia Kangaju made a few announcements, including congratulations to rising freshman Aidan Peters for named a 2018 National Maverick All Star and will attend the National Maverick Lacrosse Academy. She offered a reminder to all West and East athletes planning to participate in fall sports that they should register online by Wednesday, August 1. Ms. Kangaju noted that the West Theater Department had cast their fall musical, Disney's *Newsies*. The show will open in late October. She added that the West Theater Department will be putting on an additional fall show, *Almost Maine*, and their spring musical will be *Chicago*. Ms. Kangaju also said that four West Thespian members will perform in *A Chorus Line* at the Curtain Call Performing Arts Center in Mt. Laurel on August 8, 9, 10 and 11.

Cherry Hill High School East Alternate Representative Craig Robinson mentioned that Cherry Hill East 20th and 40th reunions were taking place this summer and in September, respectively. He noted that the auditorium roof at East was being repaired. He mentioned the bi-annual East/German student exchange with Pulheim Gymnasium, which took place on June 27-July 17. The trip include stops in Iceland and Berlin. Mr. Robinson noted that cheerleading and lacrosse camps were underway and that a "multitude" of sports camps would be offered for student athletes during the summer. Registration is open for all fall sports, he added. He mentioned the summer lacrosse camp for ages K-9th grade, hosted by East high school players. Mr. Robinson also said the Common App Workshop for parents and students took place on July 17 and 18.
